

~ My Alcohol Fueled Rock Concert ~

What it was like. Well, here's an example.

I split up with my ex-husband in 1986. I'd had enough of bruises, broken bones, and blood so I packed my bags and walked out the door. At the time, I had ordered tickets to see *Heart* at Irvine Meadows Amphitheater. In those pre-internet days you could order tickets by phone and they would mail them to you.

The tickets became a point of contention between my ex and I. I was sure he wouldn't let me have them, but surprisingly he used them as bait to get to meet with me when I was refusing to see him.

I gave the second ticket to my friend Joe because he'd been helping me move and off we went to see *Heart*. I remember the first two songs. *Heart* sounded wonderful and everybody was rocking out. I remember standing on my seat, with my drink in my hand, singing along.

The next thing I knew, Joe was shaking my shoulder and asking if I was ok to drive. He had taken me back to my car in Anaheim and I had to drive to Whittier, about a 30-minute drive. Looking back, I am amazed that I would drive in that condition. But, I did it all the time and I made it to Whittier unscathed.

I drank, drove my car, took a lot of outside issues, and partied like it was 1999 for many years. By the grace of God I never went to jail and never got a DUI. I found my way into the rooms of AA in 1988, but didn't get sober until 1989 because it took some doing to put the brakes on the runaway train that my life had become.

I really just wanted to stop taking cocaine when I first started going to meetings. I didn't think alcohol was a problem at first, but I had an epiphany less than a month into sobriety when I passed by one of my favorite bars and my mouth was watering for a glass of white zinfandel wine. The fog was starting to clear. I knew I had to stop using all mind altering substances.

I went to meetings most days for the first couple of years. I had a meeting where I knew people for every day of the week. I got into a lot of service work. I was an intergroup rep, a GSR, had an H & I panel and took meeting commitments. I've gone to meetings that dwindled and died out. I helped with a Cocaine Anonymous newsletter until I showed up for a meeting with them and I was the only one there, so that fizzled. You have to be willing to go to any lengths to stay sober.

I wish I'd never have to hear about another drunk driver killing someone with their car, but it happens all the time. For us, alcoholics, there's no such thing as moderation. There is a line from a song by *Heart "any thoughts of moderation would soon disappear"*. I would listen to that and take as many drugs and drinks as I could, but not anymore. I still sing it though, but only when I'm by myself because I don't have a voice like *Ann Wilson* and I don't want to torture anyone.

The program of *Alcoholics Anonymous* really works. I've stayed sober since 1989. If I can do it, anyone can. All it takes is the desire to stop drinking.

The wife of a Spanish-speaking A.A. member in Los Angeles in the early 1940s made the first translation of a pamphlet "A.A."—into Spanish. (Her husband, Gilberto, started the first A.A. group in Monterey Nuevo Leon, Mexico, though it did not last — and Gilberto did not stay sober.)

A few years later, in March 1946, according to an article in the Cleveland Bulletin (Vol. IV-No. 8, May 1946, p. 4) at the time, a Spanish-speaking A.A. member, Ricardo P. (Dick P.) of the Mexican Consulate in Cleveland, presented Bill W. with a copy of the Big Book in Spanish. The article identified Dick as the first Spanish-speaking member of the Fellowship and said that he had translated the Big Book with the help of his wife. The work reportedly took three years but, sadly, that translation has disappeared.

Frank M., who was born in Puerto Rico, finished his translation of the Big Book into Spanish in 1947. Referring to Frank in Alcoholics Anonymous Comes of Age (published in 1957), Bill W. says: "He worked daytimes as an interpreter for a New York importer and at night he labored over his love, Alcoholics Anonymous. Today his translation is the foundation cornerstone for A.A. in Spanish-speaking countries." (page 200)

Copies of the book were sent to Mexico and Puerto Rico and New York, though it was not mass-produced until the early \$ 1950s. Frank's translation was used in El Salvador, Colombia, the United States, and Mexico. Several editions of the book

The early lack of translated material had an adverse im-pact on the growth of A.A. in Latin America. There is evi-dence of A.A. groups being started by non-alcoholic profes-sionals that faded eventually, in part due to the lack of litera-ture. Dick P. tried unsuccessfully to help establish A.A. in Mexico in 1946, giving a talk about A.A. in that country. One story is that his ≥ address was given so much advanced cover-age that the beer companies tried to impede the presentation.

There is a great debate regarding where A.A. first took root in Latin America, with Guatemala, El Salvador, Mexico, Puerto Rico, and Colombia named as possibilities. In any case, these are the countries were A.A. grew early on. Carlos A. in § Mexico created a publication "Mis Ojas Sueltas" ("My Loose Leaves"). In it were excerpts of the Akron pamphlets translated ≤ into Spanish, among other A.A. historical material. The spirit of perseverance and hope is evident in these early efforts to bring A.A. to the Spanish-speaking world, and well-established in the 21 countries where Spanish is the official language.

QUESTIONS AND ANSWERS...

Box 4-5-9 Vol. 54, No. 1 / February-March 2008:

Q. What are the origins of the Serenity Prayer?

A. Most evidence indicates that the Serenity Prayer was written by Dr. Reinhold Niebuhr, a theologian who served for many years as dean and professor at the Union Theological Seminary in New York City. (Coincidentally, one street adjoining the building where G.S.O. is located is Reinhold Niebuhr Place.) A service piece on the Serenity Prayer ("Origin of the Serenity Prayer: A Historical Paper"—item SMF-129) may be obtained from G.S.O.

Q. Does G.S.O. have information about the history of my home group?

A. G.S.O.'s Archives staff may sometimes be able to provide information about the origins and history of a group, depending on the amount of information the group has sent to G.S.O. over the years.

Q. Who wrote Chapter 8 of the Big Book, "To Wives"?

A. Bill was the author of the "To Wives" chapter, despite the common misconception that Lois wrote it. In "Pass It On" (page 200), Lois says: "Bill wrote it, and I was mad.... I wasn't so much mad as hurt. I still don't know why Bill wrote it.... I said to him, 'Well, do you want me to write it?' And he said no, he thought it should be in the same style as the rest of the book."

Q. Is ICYPAA (the International Conference of Young People in A.A.) a part of A.A.?

A. Yes, ICYPAA is a part of A.A., as are young people in A.A. committees at the state and regional levels, as long as the events they organize are run by A.A. members, for A.A. members, and there is no other affiliation. ICY-PAA is listed in our confidential A.A. directories under "Special International Contacts."
