As AA members, too often our experience of individuals with disabilities can limited to that of persons with orthopedic disabilities, visual impairments or hearing impairments.

It is much broader than that because all of us who identify as alcoholics are recognized as individuals with a disability under the Americans with Disabilities Act Title I

Title I covers the area of employment. Title I forbids private employers, state and local governments, employment agencies, and labor unions from discriminating against qualified individuals with disabilities in: Job application procedures, Hiring, firing, advancement and Job training only. It is up to all of us to become disability aware.
