**ASC Minutes**

Meeting was called to order by Chairwoman Sharon at 12:20p.

**Readings:** Declaration of Unity read by Lisa in English/Pedro in Spanish. The Statement of Purpose and Membership read by Glen in English/Rafael in Spanish. GSR Preamble read by Anthony in English/Carlos in Spanish.

**Introductions:** Past Trustees, Past Delegates, New DCMCs/Alt. DCMCs, New DCMs/Alt. DCMs, New GSRs and Alt. GSRs, Guests, Past and Current Area Officers.

**Approval of minutes** Motion to approve by Scott R. and seconded by Chad. Kitty noted a wrong time and Jeryl noted that the Secretary's report was missing. Minutes passed unanimously as amended.

**Officers/Directors Reports (following reports are written reports):**

**Delegate Cesar:** My name is Cesar and I am an alcoholic; I have the honor and privilege to serve as your Panel 64 Area 09 Delegate. Since the last ASC I was able to attend several functions in our Area; I attended the Board Meeting, I participated with the Concepts 7-12 for 30 minutes at the Came To Believe Group in Corona, Public Information at the Grupo Once de Enero group, and I attended the 4 Area DCM Sharing Session. It was so nice to see friends from Area 08, 05 and 93!  
At end of this month I am planning to attend the All California Young People in AA Conference in San Jose, CA. District 10 & 15 are having a combined roundtable workshop on Feb 21st.  
The 65th General Service Conference; I bought my flight ticket. I filled out the hotel reservation form and sent it to the Conference Coordinator. I am so excited!  
The Agenda Items will be available soon, as well the background information. Our Alt Delegate Joe C has an enthusiastic group of people ready to summarize the background info and then translate it into Spanish. PRAASA is around the corner and I am looking forward to that; this is going to be my 13th PRAASA. I will encourage everyone to attend it as it is one of the most amazing events I have ever experienced. The event will be hosted by Area #69, and is going to be in Layton, UT on March 6, 7, and 8.  
International Convention; Excitement continues to build for the big party in Atlanta on July 4th weekend to celebrate 80 years of AA – Happy, Joyous, and Free. Registration so far exceeds 34,000, and demographics are skewing older than last time. Deadline for online registration is May 12, 2015. After that you will have to register onsite. I have my hotel reserved and my flight booked too. This is going to be my first International Convention and I am very much looking forward to it!  
From AAWS: GSO welcomed 1,942 visitors in 2014, including international visitors from Argentina, Hungary, Norway, and Qatar (just to name a few). Total gross sales for 2014 were \$17,128,000, which was \$2,152,100 over budget. 1,140,000 print copies of the Big Book were distributed in 2014, plus 20,000 in Ebook format. The next titles planned for the conversion of all titles to Ebooks are Pass It On, Dr. Bob and the Good Oldtimers, and Experience, Strength, and Hope.

A special booklet, "A Brief History of the Big Book" is being offered free of charge with each commemorative Big Book sold. The booklet is also being offered for sale in ten-packs. In addition, a brochure entitled, "They Needed a Book" is being prepared. It's based on an Archives exhibit about the origin of the Big Book. Plans are for it to be available before the International Convention.

From the AA Grapevine, Inc.: Circulation of the print Grapevine magazine averaged 74,000 in 2014. La Viña circulation averaged 10,379. Gross profit for the Grapevine magazine was \$1,529,063, which is \$146,945 ahead of budget. Net profit on Grapevine was \$325,827. Gross profit on La Viña was \$59,447, which is \$2,180 ahead of budget. La Viña expenses exceeded revenue by (\$132,026), which is less than the budgeted amount by \$9,548. The subscription challenge kicked off on Feb. 1. New subscriptions are going to be essential to keep Grapevine from slipping into the red over the next few years, so they asking us to put forth some effort to spread the word about the subscription challenge, it would be appreciated. Planning continues for the development of a version of the Grapevine for mobile devices. The audio book of The Language of the Heart is planned to be made available in the first quarter of 2015.

Archives - In 2014 the Archives staff responded to approximately 1,480 requests for information and research. The archives staff also assisted many on-site researchers with their research projects. The Archivist noted to the Trustees' Archives committee that the Deed of Gift form should be amended to include an addendum for accepting digital items, and the committee will review the Deed of Gift form at its next meeting in August.

CPC/Treatment/Special Needs-Accessibilities - In January, Class A trustee Ivan Lemelle, Class B trustee Chet P, and GSO Corrections staff Clement C, gave a panel discussion entitled "Myths and Misconceptions about Alcoholics Anonymous" at the American Probation and Parole Association Convention in Tampa, FL. It was standing room only, there were lots of questions, and professionals attending the panel reported that the message that AA is a design for living that is transformational was especially illuminating. Class A trustee John Fromson will speak in May in San Francisco to the American Academy of Physician Assistants, and the local CPC committee will be staffing a booth. The efforts of Racy J, GSO CPC staff to schedule more events at professional conferences are really paying off.

Finance and Budgetary - Some of the main numbers for 2014 for AAWS and AA Grapevine, Inc., were reported above in the sections on the corporate boards. In addition, I'll report here that 2014 contributions were \$6,898,100, which is \$101,900 less than budget. Still, because of strong sales, net profit was \$1,376,656, which is \$1,181,200 more than budget (pretty much equal to the large Hazelden literature purchase that took place just before the literature price increase in October). The 2015 GSO budget has been developed. It projects net sales of \$14,570,000, contributions of \$7,000,000, and a net profit of \$197,125. The 2015 AA Grapevine, Inc., budget has also been developed. It projects total income of \$2,113,375 and a projected loss of (\$14,606). The 2015 La Viña budget projects a gross profit of \$56,973 on the magazine, \$9,298 on related items, and a net shortfall after expenses of (\$159,457). As of December 31, 2014, the Reserve Fund balance was \$14,094,966, which is approximately 9.7 months of operating expenses. When the 2015 budgets of the operating corporations are considered, along with the \$1 million cash needs for the relocation of the Grapevine from the 12th floor to the 11th floor, the ratio will likely decrease.

International - Rick W, GSO staff, reports receiving correspondence from countries around the world, including Albania, Colombia, Great Britain, Iran, Israel, Kenya, Macedonia, Poland, South Korea, and Ukraine, just to name a few. In Albania and Macedonia, new groups started for the first time last year. The Final Report of the 23rd World Service Meeting is scheduled to be available in late February.

In terms of International travel, trustees, staff, and/or management are scheduled to make the following trips in 2015: 11th Mexican Convention of AA; AA Japan 40th Anniversary; Sub-Saharan Africa Service Meeting (Johannesburg, South Africa); Meeting of the Americas (Mexico City); European Service Meeting (York, England); Asia-Oceania Service Meeting (Dubai); Ukraine General Service Conference.
