Concept Six – The

An anonymous A.A. member in Orange County

“The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.”

Now, wait a minute, you say! All along you have been telling us that the Groups are the boss. This concept says, flat out, that the General Service Board has “chief initiative and active responsibility in most world service matters”. That sounds an awful lot like a definition of “boss”.

The 12 Concepts For World Service, when taken as a whole, define legal authority as opposed to practical authority. Because the General Service Board, through its charter, is a legal entity, it must be governed by legal language. This language gives the General Service Board the chief initiative and active responsibility listed in this Concept.

Bill W. basically set up the A.A. Service Structure along the lines of a corporation. In Bill’s essays on the 12 Concepts, found in the A.A. Service Manual, he outlines his reasons for choosing that structure, as opposed to an institutional or government-like structure (the what!? That’s right, we actually have An A.A. Service Manual – check it out at the Central Office, or online at aa.org under SERVICES FOR MEMBERS). However, and this is vital to the working relationship between the General Service Conference and the General Service Board, the Board has always realized that the practical authority held by the Conference grants the power of a final decision to the Conference. The Board has NEVER vetoed or over-ruled the Conference. And we’ll see why next month in the report on Concept VII.

Concept 7 – Legal vs Traditional Authority

Concept 7 (short form) The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.

This concept spells out the exact relationship of the General Service Board to the General Service Conference, and therefore to the A.A. Groups. It says that the General Service Board, out of necessity, is given legal authority, through the Charter and Bylaws of the General Service Board, (whoa, doesn't that sound like legal terminology!) to manage the affairs of the General Service Office and the two legal corporations – Alcoholics Anonymous World Service (AAWS) and the A.A. Grapevine. I can hear you now, "Hey, you told us earlier that the Groups are in charge. This sounds like some board of trustees is making all the decisions". *Please read past the semi-colon in the Concept short form.*

The concept goes on to say that the General Service Conference, representing the Groups, relies upon tradition and the A.A. purse for final effectiveness. In the long form, it is much more descriptive – it says that the General Service Conference "... relies instead upon the **force** of tradition and the **power** of the A.A. purse for its final effectiveness" (Italics, bolding and underlining added by author). Looking especially at Traditions 2 and 9, we see that the **ultimate** authority comes from the Group conscience, and that the Service Boards and Committees are directly responsible to those they serve. This is the force of tradition spelled out in this concept.

But what about the *power of the purse*, what is that? In the power of the purse lies the ultimate power, one that has never had to be used on a massive scale. This is where the Groups simply withhold their voluntary contributions to the General Service Office, (G.S.O.) because they believe that the General Service Board, or the General Service Conference has grossly erred in their decision(s). Without voluntary group contributions, G.S.O. would cease to operate. Strong medicine, indeed! It should be evident that the *power of the purse* works at all levels of service, G.S.O., the District Committee, the Area Assembly, Central Office and the Hospitals & Institutions Committee. All service boards and committees must remember that the A.A. Groups hold the purse strings. The consequences of ignoring this power invested in the A.A. Groups are dire.



Area 09 Mid Southern California FORO #16 will meet on July 8th 2007 at Mayfair park Clark Avenue, Lakewood CA.

Memories of the 1992 Foro: Memories of the first Foro of M.S.CA. 09 are that at the time there were only 4 Spanish speaking districts and they were districts 20, 21, 22, and 23. It was in the year 1992 that district 23 made an inquiry about starting a Foro for General Service, and from that day forward they started meeting the last Sunday of the month. At that time there were only a few Spanish speaking people that would get involved in Area meetings such as PRAASA, SERVATHON, REGIONAL FORUMS, PRE CONFERENCIA workshops, and other General Service Office events.

That was the beginning of this event and, with the help of the four districts, it paved the way for the first FORO called LIGHTING THE ROAD FOR OTHERS. The day was December 13th in the city of Riverside and the officers of the area were invited and were present at this event.

Soon later the meeting started planning the second FORO and district 21 requested that each district have a liaison present. Well then, a person attending the meeting at district 21 that was not known to the group reported to the group that he had been in the program for a long time and asked the group if he could have the opportunity to be of the service. He would like to be the chairperson and after a few months he collected the money from the 7th tradition and he took the money and was never heard from again.

So for what he did, Area 09 was responsible for the cost of the event of the Foro. Because of what happened, the area then asked for help with setting guiding principles for this event. A member, Manuel I (deceased), said he would do it and he carefully worked out the details and the event should be for the area and not just the Spanish Foro. We realized we are all in the same area geographic area 09 and the event would be called the Foro of the area since we all participate here. A.A. being just one, and it does not matter what language is spoken.

And that is the way it was done, even though some did not agree, and but for the grace of God, it was accepted.

According to the guidelines of the first Foro, each event will be hosted by one Spanish Speaking district and one English Speaking district. And it is still being done now.

The committee's main objective is to designate each year what districts will be responsible to host this event and make sure it is decided before January so we can have it on the agenda for next year. Also if a group is not responsible, we will have time to make a change. And it would give them a time to come up with their theme and emblem. That's the way FORO #16 was done with the theme (NOSOTROS YA SALIMOS) .."WE HAVE COME OUT" this theme was made by a member of the group Ultimo Milagro.





Tradition 6 (long form)

Our A.A. experience has taught us that:

Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. – and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
