Concept Five – The Right of Appeal

An anonymous A.A. member in Orange County

Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

This Concept is commonly referred to, (when referred to, at all) as the "right of the minority to speak". Of all the 12 Concepts for World Service, this Concept is probably the most familiar to the Fellowship as a whole. Who wouldn't want a Concept where they are always guaranteed the last word, as long as we vote against everything. And, unfortunately, that is usually the case – the people who vote against everything are offered the chance to get the last word in.

Now, that is the callous way to look at, and who wants to come off as callous? Certainly not me. So let's take a look at it another way. Suppose that there was a proposal made at the monthly Orange County Intergroup meeting to close the Central Office and let the Groups fend for themselves. The arguments on both sides are persuasive and compelling, but the argument to close the office wins out. The Intergroup Reps just sit there stunned! How do they go back to their groups and explain that there will be no more Central Office in Orange County?! Surely, all is lost! But, a solitary figure stands up and asks for the "right of the minority to speak" – the "right of appeal". One by one, the Intergroup Reps stand up and state their reasons that they believe the Central Office should remain open. You see, they hadn't stood up during the discussion because they never believed that it could happen – the closing of the Orange County Central Office! This Concept has given them the opportunity to express themselves as representatives of their groups. A re-vote is called for and the re-vote defeats the proposal to close the Central Office. Whew!!!!

Far-fetched? Maybe, maybe not. But matters just as dire to our Fellowship are being discussed every day somewhere in the world. I recall one year our Delegate came back from the General Service Conference and stated that the proposal to create the pamphlet "To the Black/African-American Alcoholic" had been defeated by the Conference, but a Class "A" member of the General Service Board had exercised the "right of appeal" and the Conference completely changed their minds, (after much loving discussion) and voted to develop the pamphlet, given the new experience and information offered by a single member.

The exercise of this cherished "right of appeal" has often turned the tide – a lot more often than you probably think. Concept 5 – what a Concept!!


A member of A.A. in Orange County





From Brea: Head south on CA-57 toward SANTA ANA (then drive 9.7 miles). Merge onto CA-22 W toward LONG BEACH (drive 4.8 miles). Take the exit toward BROOKHURST ST (drive 0.2 mi.) Turn RIGHT onto TRASK AVE. (drive 0.1 miles). Turn RIGHT onto BROOKHURST ST. (drive 2.8 mi). Turn LEFT onto THISTLE AVE. (drive <0.1 mi.). End at **16400 Brookhurst St**



From Long Beach: Head south on I-405. Take the WARNER AVE EAST exit- EXIT 15A. (drive 0.2 miles). Merge onto WARNER AVE. (drive 0.7 miles). Turn LEFT onto BROOKHURST ST. (drive 0.6 miles). End at **16400 Brookhurst St**



From Palm Springs: Head west on I-10 (drive 18.5 miles). Merge onto CA-60 W via the exit on the LEFT toward RIVERSIDE (drive 22.9 miles). Take the CA-91 S exit toward RIVERSIDE / BEACH CITIES (drive 0.3 miles). Take the CA-60 exit toward LOS ANGELES (drive 0.2 miles). Merge onto I-215 S. (drive <0.1 miles). I-215 S becomes CA-91 W. (drive 22.5 miles). Take CA-91 EXPRESS LN toward 91 EXPRESS TOLL (Portions toll) (drive 8.3 miles). Merge onto CA-55 S. (drive 5.1 miles) Merge onto CA-22 W toward LONG BEACH (drive 7.6 miles). Take the exit toward BROOKHURST ST. (drive 0.2 miles). Turn RIGHT onto TRASK AVE. (drive 0.1 miles). Turn RIGHT onto BROOKHURST ST. (drive 2.8 miles). Turn LEFT onto THISTLE AVE. (drive <0.1 miles). End at **16400 Brookhurst St**

The GSR – Part II

Why Do We Need a General Service Conference?

The late Bernard B. Smith, non-alcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting.

“We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined to alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.

“We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect against disintegration while preventing over-integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

“We need it to ensure that all changes within A.A. come only as a response to the needs and wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unmasked and feel welcome. We need to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is”.

So there you have it. We need a General Service Conference to ensure that all who suffer from alcoholism, for as long a time as God may need us, will find what you and I found in A.A. But the first sentence of the final paragraph, above, should be troublesome to each and every one of us. The membership of any General Service Conference is made up elected Delegates from the 93 delegate areas of the United States and Canada, along with the members of the General Service Board, defined General Service Office staff and the directors of our two service corporations – Alcoholics Anonymous World Services, (AAWS) and the A.A. Grapevine. This is what Mr. Smith refers to when he states “...*that all changes within A.A. come only as a response to the needs and wants of all A.A., and not of any few*”. When our delegate area, Mid-Southern California Area 09, elected our delegate in October of 2005, approximately 60 of the 1900+ groups in our Area cared enough to send a General Service Representative, (GSR). This situation is nothing less than a broken promise to those who *stumble in the darkness*, having not yet found A.A. - a broken promise to that *child being born tonight, destined to alcoholism*, who will someday seek a haven in the rooms of A.A. Remember, the Responsibility Statement we find printed on most pieces of A.A. pamphlet literature does not say that the man or woman sitting next to me is responsible, it states very bluntly – I AM RESPONSIBLE!
